WESTTOWN TWP:

Officers arrested a 32 year old male and charged him with Disorderly Conduct, Resisting Arrest, Public Drunkenness, Resisting Arrest, and Trespass following a disturbance that occurred at a residence in the 900 block of Tyson Drive.

Officers arrested a 53 year old female and charged her with Public Drunkenness. The subject was arrested after Officers found her staggering along the road in the 1600 block of West Chester Pike.

Officers arrested a 19 year old male and charged him with Underage Drinking. The subject was arrested after Officers discovered him walking in the roadway in the 1100 block of Dodgson Road.

Officers arrested a 53 year old female and charged her with Harassment. The subject was cited following an incident that occurred with the owner of the neighboring property owner in the 700 block of Oakbourne Road.

Detectives served a search warrant on a home in the area of Marlboro Road. A subject was arrested on outstanding drug charges and is the ongoing subject of a drug investigation.

Officers conducted a traffic stop on Rte 202 after hearing a description of a robbery/retail theft that occurred in West Whiteland Twp. The traffic stop resulting in the suspects being taken into custody and turned over to West Whiteland Twp.

EAST GOSHEN TWP:

Officers arrested a 30 year old female and charged her with Driving Under the Influence. The subject was stopped after an off duty Officer called in an erratic driver complaint in the area of Strasburg Rd and Dutton Mill Rd.

Officers arrested a 35 year old male and charged him with Driving Under the Influence. The subject was arrested after being stopped for a motor vehicle violation in the 1300 block of Paoli Pike.

The Westtown East Goshen Police Department conducted a DUI/sobriety checkpoint in the 1300 block of West Chester Pike. During the checkpoint a 25 year old male, a 32 year old male, a 47 year old male, a 64 year old male, and a 65 year old male were arrested and charged with Driving Under the Influence. Additionally a 20 year old male was charged with Underage Drinking.

Detectives are investigating a burglary that occurred at a residence in the Cider Knoll Townhomes. Unknown suspects entered the victim's residence and removed cell phones, GPS unit, and various household items.

Detectives are investigating numerous thefts from vehicles in and around the Paoli Pike corridor. Both unlocked and locked vehicles have been entered and various items stolen.

Detectives are investigating a burglary that occurred in the 1300 block of Greenhill Road. Unknown suspects forced entry through a door and removed alcohol from the structure.

Detectives and Patrol Officers responded to the 200 building of New Kent Drive for a missing person. After extensive investigation it was determined that the missing person was a known drug addict and was suffering suicidal tendencies. The investigation resulting in the subject agreeing to return to the area at which time he was sent to the hospital to undergo a mental health evaluation.

THORNBURY TWP:
