Monthly Activity Report August 2011

Westtown Twp:

Officers arrested a 45 year old male and charged him with Driving Under the Influence. The subject was taken into custody after being stopped for a motor vehicle violation in the 1600 block of West Chester Pike.

Officers arrested a 40 year old male and charged him with Driving Under the Influence. The subject was taken into custody after being involved in a motor vehicle accident in the 1500 block of West Chester Pike.
