

Westtown East Goshen Regional Police Department

Monthly Activity Report

December 2011

Westtown Twp:

Officers arrested a 22 year old male and charged him with Driving Under the Influence. The subject was taken into custody after driving over a fire hose at the scene of a vehicle fire in the 1500 block of East Street Road.

Officers arrested a 25 year old female and charged her with Driving Under the Influence. The subject was taken into custody after being stopped for a motor vehicle violation in the 1100 block of Wilmington Pike.

Officers arrested a 68 year old male and charged him with Public Drunkenness. The subject was taken into custody after being found to be sleeping in the Westtown Marketplace Shopping Center while heavily under the influence of alcohol.

Officers arrested a juvenile male and charged him with Underage Drinking. The subject was taken into custody after being found manifestly under the influence of alcohol while on the grounds of Westtown School for an athletic event.
