

**THORNBURY TOWNSHIP, CHESTER COUNTY
BOARD OF SUPERVISORS
REGULAR MEETING
MINUTES September 18, 2018**

CALL TO ORDER:

The regularly scheduled meeting of the Thornbury Township Board of Supervisors was called to order by Bob Anthony - Chairman at 7:00 PM in the Thornbury Township meeting room. In attendance were Supervisors, Joe Lisa via telephone, and Bill Reilly. Judy Lizza, Township Manager, and Kathy Labrum, Township Solicitor and Teresa DeStefano, Township Secretary were also in attendance. The Pledge of Allegiance was conducted by Bob Anthony.

APPROVAL OF MINUTES:

Bob Anthony motioned to approve the August 21, 2018 Board of Supervisors' Meeting Minutes and the September 4, 2018 work session minutes. The motion was seconded by Bill Reilly. All were in favor. Motion carried.

Judy Lizza gave a summary of the report and stated that a copy of the complete manager's report is on file for your review.

AGENDA BUSINESS:

Approval of the Vision Partnership Program Contract with Chester County Planning to update the Zoning Ordinance

Bob Anthony moved to approve and execute the Vision Partnership Grant contract with Chester County Planning. Seconded by Bill Reilly. All were in favor. Motion carried.

Zoning Ordinance Update Commission: Establish membership of Committee; Announce the Meeting dates

Bob Anthony moved to appoint the following to serve on the Commission to Update the Zoning Ordinance: Peter DuFault, Ryan Estrada, Bob Wiggins, and Tony Priestley. Supervisor Joe Lisa will be the Liaison to the Board. The meetings shall take place the last Wednesday of each month at 7 PM at the Township Building. The first meeting is October 31st. Seconded by Bill Reilly. All were in favor. Motion carried.

Resolution 2018-15 Appointment to the Zoning Hearing Board

Bill Reilly moved to approve Resolution 2018-15 appointing Christine Kimmel to the Zoning Hearing Board to fill the vacancy. This term expires December 31, 2018. Seconded by Joe Lisa. All were in favor. Motion carried.


