

**THORNBURY TOWNSHIP, CHESTER COUNTY  
BOARD OF SUPERVISORS  
REGULAR MEETING  
MINUTES December 18, 2018**

**CALL TO ORDER:**

The regularly scheduled meeting of the Thornbury Township Board of Supervisors was called to order by Bob Anthony - Chairman at 7:00 PM in the Thornbury Township meeting room. In attendance were Supervisors, Bob Anthony, Jim Benoit, Joe Lisa and Bill Reilly. Judy Lizza, Township Manager, and Kathy Labrum, Township Solicitor, were also in attendance. The Pledge of Allegiance was conducted by Bob Anthony.

**APPROVAL OF MINUTES:**

Bob Anthony motioned to approve the November 13, 2018 Work Session, the November 20, 2018 Board of Supervisors' Meeting and the December 4, 2018 Work Session minutes. The motion was seconded by Jim Benoit. All were in favor. Motion carried.

Bob Anthony moved to approve Resolution 2018-19. Seconded by Jim Benoit. All were in favor. Motion carried.

Discussion with Scott Megill regarding 4 Huntrise lane.

Brief discussion regarding the possible future plans for 4 Huntrise Lane. Megill may need to apply to the Zoning Hearing Board and wanted to know the Board's opinion. Megill may want to renovate the cottage and create a residential house from the barn; this would create two single family dwellings on one lot. Members of the Historic Preservation Commission (HPC) were also present at the meeting. Megill was directed to develop additional structure to the concept with the HPC.
