

**THORNBURY TOWNSHIP, CHESTER COUNTY
BOARD OF SUPERVISORS
REGULAR MEETING
MINUTES June 16, 2020**

CALL TO ORDER:

The regularly scheduled meeting of the Thornbury Township Board of Supervisors was called to order by Robert Anthony at 6:15 PM remotely via Ring Central. In attendance were Supervisors Robert Wiggins, Mike Gallagher, and Joe Lisa. Judy Lizza, Township Manager, and Kathy Labrum, Township Solicitor, were in attendance.

Karen Griem, Brooks Durham, and Paul Nichol residents were online for public comments.

Bob Anthony read the following:
