CALL TO ORDER:

ITEMS ON THE AGENDA:

1. Sage Hill Community request to extinguish walking trail.

The Board of Supervisors discussed the request and has directed the Manager to write to the HOA in favor of the trail removal with the following conditions: the HOA documents would need to be updated, the plan would need to be updated and rerecorded, and that a permanent easement be provided to the Township where the trail exists today.

2. Cheyney University parking on surrounding Township roads

This issue will be further discussed with Cheyney University for resolution.

3. Town Center Snow and Ice Control Contract

- Good Fellowship Ambulance Company \$15,613.18


Joe Lisa motioned to approve the bill list for June . The motion was seconded by Eric Burling. All were in favor. Motion carried.
