

RESOLUTION NO. 2026-02

A RESOLUTION APPOINTING AGENCIES TO PROVIDE EMERGENCY SERVICES TO THORNBURY TOWNSHIP, CHESTER COUNTY, PA

WHEREAS, the Board of Supervisors of Thornbury Township, Chester County is responsible under the Second-Class Township Code for the public safety of Township residents; and

WHEREAS, the Board of Supervisors desires to fulfill its public safety responsibilities by appointing certain agencies that will provide rescue, ambulance and fire protection services to Thornbury Township, Chester County.

WHEREAS, the Board of Commissioners of the County of Chester has requested that Thornbury Township provide a Resolution outlining the methods and agencies chosen to fulfill the public safety needs of Thornbury Township for the efficient administration of the integrated emergency communications system of the Chester County Department of Emergency Services.

NOW THEREFORE, IT IS HEREBY RESOLVED the West Chester Fire Department will provide fire protection. West Chester Fire Department chooses to use Automatic Vehicle Location services instead of being designated a primary service or chooses a combination of designated primary coverage area and the use of Automatic Vehicle Location services.

FURTHER, BE IT RESOLVED the Good Fellowship Ambulance and Concordville Ambulance will provide ambulance services; and

FURTHER, BE IT RESOLVED the Pennsylvania State Police will provide full time police protection; and

FURTHER, BE IT RESOLVED the West Chester Fire Department will provide fire and rescue services; and

FURTHER, BE IT RESOLVED that Good Fellowship Ambulance and Concordville Ambulance provide Advanced Life Support Services; and

FURTHER, BE IT RESOLVED that F. David Smiley is designated as Emergency Management Coordinator and Fire Marshal; and Alfred Smiley as Deputy EMC and Deputy Fire Marshal; Audrey Hudak as Deputy EMC; and

FURTHER, BE IT RESOLVED that the Board of Supervisors has reviewed and revised, if necessary, and adopted Thornbury Township Emergency Operations Plan; and has reviewed and adopted the National Incident Management System as a common operating practice.




